They argue that intrinsic motivation, which arises from the inherent satisfaction of the activity itself, is more sustainable and effective than extrinsic motivation, which is driven by external rewards and pressures. The study explores various strategies for fostering intrinsic motivation within organizations. These include providing employees with meaningful work, opportunities for skill development, and a supportive work environment that encourages autonomy and collaboration. Ryan and Deci emphasize that while extrinsic rewards can be effective in the short term, they often fail to sustain long-term motivation and can even undermine intrinsic motivation if not implemented thoughtfully.

The authors also discuss the implications of their findings for performance management systems. They argue that performance appraisals should focus on developmental feedback rather than merely evaluating past performance. By emphasizing growth and learning, organizations can help employees find intrinsic value in their work, leading to higher levels of motivation and engagement.

## Theoretical Framework for Effective Motivation Techniques Self-Determination Theory (SDT)

Self-Determination Theory (SDT), developed by Ryan and Deci (2020), is a robust framework for understanding human motivation and its impact on performance. SDT posits that motivation can be classified into intrinsic and extrinsic types, each driven by different factors. Intrinsic motivation stems from the inherent enjoyment or satisfaction derived from the activity itself, whereas extrinsic motivation is driven by external rewards or pressures. The key components of SDT are i. **Autonomy**: The need to feel in control of one's own behavior and goals. ii. **Competence**: The need to gain mastery of tasks and learn different skills and iii. **Relatedness**: The need to feel a sense of belonging and attachment to others.

SDT suggests that when these needs are met, employees are more likely to experience intrinsic motivation, leading to enhanced performance and engagement. Effective motivation techniques based on SDT include providing meaningful work, fostering a supportive work environment, and offering opportunities for professional growth and development.

## **Goal Setting Theory**

Goal Setting Theory, proposed by Locke and Latham (2019), emphasizes the importance of setting specific, challenging goals to enhance performance. According to this theory, clear and achievable goals provide direction, focus, and a sense of purpose, which can significantly motivate employees. The followings are the key principles of Goal Setting Theory:

- 1. **Clarity**: Goals should be clear and specific.
- 2. **Challenge**: Goals should be sufficiently challenging to maintain interest but attainable.
- 3. **Commitment**: Employees should be committed to achieving the goals.
- 4. Feedback: Regular feedback is necessary to track progress and make adjustments.
